## Fiscal:

# Regular Medical Assistance Revenue

MA designee from each district is listed.

Revenue has been updated for 2021/2022 as of this week.

Settle-up/Settle down for 2019/2020. Three districts are in the negative.

Settle down, DHS will take from future payments.

Going forward, Dena will be reviewing the rates a couple times a year and if looking off, can appeal the rate. Up until COVID, rates have been pretty accurate for the past 6 years.

 This MA revenue spreadsheet will be shared with the district business managers.

# **COVID Revenue Update**

For the past year and a half a Provider Relief Fund Covid money for healthcare providers that could be applied for. Schools were included as HCP's per IEPs. Applications were submitted and districts received 2-3 payments.

About two weeks ago, Lake Superior business mgr. came across an error with the Phase 3 application. Previous MA revenue was reported incorrectly in the applications without decimal points, which indicated an amount 100 times more than actual. PRF Revenue was supposed to be 2% of that.

Due to this error, districts received way too much. NLSEC is working with HHS on how to fix this. NLSEC will be reaching out to districts on how the money has been spent in order to do the required reporting until a solution is known.

# **Contracted Services Review**

This spreadsheet shows all outside contracted special education services for NLSEC member districts.

Wrenshall is not sure if they will continue with Presence Learning for speech services. They might look at posting for a therapist for next school year. Cromwell contracts speech out and it's for 4-days per week. Suggested to Cromwell to reach out if they need help with speech therapy. Barnum, Moose Lake and Willow River changed from an independent contractor for Occupational Therapy to an OT hire shared between them, board approved in December of 2021. This resulted in a model change for Barnum and Moose Lake from COTA/OT to just OT for services.

Cloquet is the host district and has posted a position for the leave of absence.

## Director's Report:

Fun to Start -

**COVID Special Education Recovery and Supports** 

Recovery Tracking for MDE has started with IEP managers.

The State of Minnesota passed a law that districts needed to offer COVID recovery meetings by December 1, 2021 to determine if any recovery supports were needed. All district staff have done a wonderful job for this. There were not many concerns from parents. If there were, the concerns are being addressed.

The tracking needs to be reported in approximately August of 2022. This has been shared with IEP managers to enter info so that it's easy to tell what is happening with the student.

There are 4 buckets of recovery to consider for each student - General Education, Revision to IEP, ESY or Compensatory Education.

MDE will ask Directors to report: How much money was associated with this recovery service? There is a pot of money for this reason. What was the money used for? If the money wasn't used, do we have to return the money?

Teached will need to have the information sent to the NLSEC before they go

home for the summer.

LETRS: Language Essentials for Teachers of Reading and Spelling

A professional development course that bridges deep, meaningful research into practical classroom success, used regardless of the literacy program that is in use. This helps teachers understand how to teach students to read and what to do if they can't read. This course is recommended by the International Dyslexia Association and MDE.

A study of teaching institutions found only 29 percent actually prepare teachers with all five essential components of literacy instruction: phonemic awareness, phonics, fluency, vocabulary, and comprehension.

MDE LETRS Training for Teachers and Facilitators

2022 MN Legislation is looking at funding more training with LETRS. NLSEC is paying for one special education teacher per district at the rate of \$300.00 per person.

# EmploymentCapacityBuildingCohort(ECBC)

There are currently 20 students across the NLSEC in 18-21 programming. Goal met! 11 of these students have obtained competitive integrated employment=the new way.

Olmstead v. United States, MN Olmstead Plan: **people with disabili es are living, learning, working, and enjoying life** in the most inclusive setting.

**Comprehensive Special Education Evaluations** 

School psychologists are also informed about this information

IDEA requires school districts to conduct a "full and individual" evaluation after a school district identifies a student as potentially having a disability. 20 U.S.C. § 1414(a)(1)(A). A comprehensive evaluation should consider the requirement that districts provide medical services for diagnostic or evaluation purposes. 34 C.F.R. § 300.34(a).

Minnesota law similarly states that a "student must be evaluated in all areas of suspected disability." Minn. R. 3525.2710, subp. 3(C)(4).
